 - (c) modify any such enactment so far as it has effect in relation to any part of the United Kingdom;

- (2) The capacity of the Gibraltar legislature to make law in relation to any matter in relation to which provision may be made under section 3 is not affected by the existence of the power conferred by that section.
- (3) Subsection (2) is not to be regarded as restricting the operation in relation to law made by the Gibraltar legislature of the Colonial Laws Validity Act 1865 (under which colonial laws are void if repugnant to provision made under an Act of Parliament).
- (4) “Enactment”, and “modification” have the same meaning as in the Political Parties, Elections and Referendums Act 2000 (see section 160(1) of that Act).’

‘SPEAKER’S COMMITTEE FOR THE REFERENDUM ON THE UNITED KINGDOM’S
MEMBERSHIP OF THE EUROPEAN UNION

- () There is to be a committee known as the Speaker’s Committee for the Referendum on the United Kingdom’s membership of the European Union (“the Committee”) to consider the arrangements for, and conduct of, the referendum.
- () The Speaker’s Committee shall consist of the Speaker of the House of Commons, who shall be the chair of the Committee, and the following other members, namely—
 - (a) the Member of the House of Commons who is for the time being the Chair of the Foreign Affairs Select Committee of the House of Commons;
 - (b) the Lord President of the Council;
 - (c) a Member of the House of Commons who is a Minister of the Crown with responsibilities in relation to foreign affairs; and
 - (d) five Members of the House of Commons who are not Ministers of the Crown.
- () The member of the Committee specified in subsection (2)(c) shall be appointed to membership of the Committee by the Prime Minister.
- () The members of the Committee specified in subsection (2)(d) shall be appointed to membership of the Committee by the Speaker of the House of Commons.
- () The Speaker’s Committee shall make a report to the House of Commons on the exercise by the Committee of their functions.’.

- (g) the National Council of Voluntary Organisations,
- (h) Friends of the Earth,

‘TRANSFER OF POWERS

- 1 Subject to section 1(a), a “transfer of power” involves one or more of the following—
 - (a) the extension of the objectives of the EU as set out in Article 3 of the Treaty on European Union;
 - (b) the conferring on the EU of a new exclusive competence;
 - (c) the extension of an exclusive competence of the EU;
 - (d) the conferring on the EU of a new competence shared with the member states;
 - (e) the extension of any competence of the EU that is shared with the member states;
 - (f) the extension of the competence of the EU in relation to—
 - (i) the co-ordination of economic and employment policies, or
 - (ii) common foreign and security policy;
 - (g) the conferring on the EU of a new competence to carry out actions to support, co-ordinate or supplement the actions of member states;
 - (h) the extension of a supporting, co-ordinating or supplementing competence of the EU;
 - (i) the conferring on an EU institution or body of power to impose a requirement or obligation on the United Kingdom, or the removal of any limitation on any such power of an EU institution or body;
 - (j) the conferring on an EU institution or body of new or extended power to impose sanctions on the United Kingdom;
 - (k) any amendment of a provision listed in Schedule 1 that removes a requirement that anything should be done unanimously, by consensus or by common accord;
 - (l) any amendment of Article 31(2) of the Treaty on European Union (decisions relating to common foreign and security policy to which qualified majority voting applies) that removes or amends the provisions enabling a member of the Council to oppose the adoption of a decision to be taken by qualified majority voting;
 - (m) any amendment of any of the provisions specified in paragraph 3 that removes or amends the provision enabling a member of the Council, in relation to a draft legislative act, to ensure the suspension of the ordinary legislative procedure.
- 2 A transfer of power also includes a reference to the removal of a limitation on a competence.
- 3 The provisions referred to in paragraph 1(m) are—
 - (a) Article 48 of the Treaty on the Functioning of the European Union (social security),

- (b) Article 82(3) of the Treaty on the Functioning of the European Union (judicial co-operation in criminal matters), and
 - (c) Article 83(3) of the Treaty on the Functioning of the European Union (particularly serious crime with a cross-border dimension).
- 4 A treaty or Article 48(6) decision does not fall within this section merely because it involves one or more of the following—
- (a) the codification of practice under the Treaty on European Union or the Treaty on the functioning of the European Union in relation to the previous exercise of an existing competence;
 - (b) the making of any provision that applies only to member states other than the United Kingdom;
 - (c) in the case of a treaty, the accession of a new member state.’
