

# **Energy Bill – Analysis on the application of Standing Order No. 83O of the Standing Orders of the House of Commons relating to Public Business in respect of amendments made at Lords Consideration of Commons Reason and those tabled for Commons Consideration of Lords Message**

1. The following is the Department’s assessment of the amendment made to the Bill at Lords Consideration of Commons Reason (LCCR) on 26 April and tabled for Commons Consideration of Lords Message (CCLM) for debate on 9 May.

## Summary

2. The amendment made to the Bill at LCCR does not affect the territorial application of the Bill<sup>1</sup>.
3. The above assessment is presented in tabular form on page 2.

## Lords non-insistence and amendment in lieu

4. The Lords did not insist on their amendment 7T to Commons amendment 7, but proposed amendment 7TB in lieu. This amendment would apply to Great Britain.

## Motion tabled for Commons Consideration of Lords Message

5. The Government has tabled a motion to disagree with the Lords in their amendment 7TB, proposed to Commons amendment 7.
