Not selected in Committee on Day 2 (out of scope): NC20 [Begum], NC31[Opp]; (starred) NC34 [Ribeiro-Addy]; clause title 201 [SNP]. Also not selected are motions to leave out Clauses, because in Committee the Question must be put on Clause stand part, subject to Standing Order No. 83D if the programming time limit (“knife”) is reached: Amendments 225, 183, 237, 303, 243, 244, 245, 51 to 58, 272, 273.

As the Bill has already been amended on Day 1, there will be a consideration (report) stage is expected. The date for any consideration (report) stage and Third Reading (which under the programme order would both be on the same day) has not yet been announced.
