Under the Programme Order of 12 December,

- if the Bill is not amended in Committee, proceedings on Third Reading will follow straight after the votes in Committee on Day 2 and must be brought to a conclusion no later than one hour after the debate starts on Third Reading; or
- if the Bill is amended in Committee,
 - any proceedings on consideration will be on a future day and must be brought to a conclusion no later than one hour before the moment of interruption, and
 - Third Reading on that day must be brought to a conclusion no later than the moment of interruption.
