Page 3, line 38, leave out from “decided” to second “so”

Page 3, line 43, at end insert “and to the content of recitals in EU Regulations and Directives”

After Clause 6

BARONESS MEACHER

Insert the following new Clause—

“United Nations Convention on the Rights of the Child

On exit day and on any day thereafter, in carrying out duties and functions that were within the competence of the EU before exit day, a public authority or Minister of the Crown must have due regard to all parts of the United Nations Convention on the Rights of the Child ratified by the UK.”

Page 6, line 25, at end insert—

“() materially change policy including by omission.”

Page 6, line 25, at end insert –

“() increase legislative burdens on individuals or business.”

“() make any provision which is not compliant with the United Nations Convention on the Rights of the Child.”

Page 6, line 25, at end insert –

“() No regulations may be made under this section altering the roles and responsibilities of the European Aviation Safety Agency until a Minister of the Crown has laid before both Houses of Parliament a report setting out the benefits and costs of any such alteration to the UK’s aviation sector, including airlines, airports, aircraft manufacturers, aircraft maintenance and air navigation services providers, in terms of capital costs, operational costs and the impact on market access and safety.”

“() It is the Government's objective, in negotiating the withdrawal of the United Kingdom from the EU, to seek continued membership of the European Economic Area and the customs union.”

“() make any provision which is not compliant with the United Nations Convention on the Rights of the Child.”
