REGISTER OF MEMBERS' FINANCIAL INTERESTS

Introduction to the Registers for the 2015 Parliament

The Register of Members' Financial Interests was established following a Resolution of the House of 22 May 1974. As Parliamentary Commissioner for Standards I am responsible, under House of Commons Standing Order No. 150, for maintaining it.

Members who were elected on 7 May 2015 were required to register their interests within one month of their election. After that Members must register any change to their registrable interests within 28 days.

The main purpose of the Register is to provide information about any financial interest which a Member has, or any benefit which he or she receives, which others might reasonably consider to influence his or her actions or words as a Member of Parliament.¹

The House has identified nine specific categories of interests which Members have to register. Each has a separate financial threshold. Members have an obligation to keep in mind the overall definition of the Register's purpose, as explained in the previous paragraph, and to record in the Miscellaneous category any interests which meet that purpose but which do not fall within any of the other categories.

The Register is updated fortnightly online when the House is sitting, and less frequently at other times. Interests remain on the Register for twelve months after they have expired.

The interests which are to be registered are set out in detail in the Guide to the Rules relating to the Conduct of Members, as approved by the House on 17 March 2015.² Interests which arose on or after 7 May 2015, the date of the General Election, are registered in accordance with this Guide; those arising before 7 May 2015 are registered in accordance with the 2012 Guide.³

Interests are listed in the Register under the following headings:

If someone alleges that a Member has not registered their interests in accordance with the rules of the House, I may investigate as Parliamentary Commissioner for Standards. If I find the allegation is substantiated, and for example the omission is minor or inadvertent, I may resolve it myself by means of the rectification procedure. In more serious cases I would expect to submit a memorandum to the Committee on Standards. Entries are printed in bold italics, with an appropriate explanatory note, when they have been made or amended following an inquiry by the Commissioner.
