CROSSRAIL BILL

PETITION

Against the Amendment of Provisions (May 2007) – On Merits – Praying to be heard by Counsel, &c.

To the Honourable the Commons of the United Kingdom of Great Britain and Northern Ireland in Parliament assembled.

THE HUMBLE PETITION of City & Provincial (Equity Partners) Limited
SHEWETH as follows:-

1. A Bill (hereinafter referred to as “the bill”) has been introduced and is now pending in your honourable House intituled “A bill to Make provision for a railway transport system running from Maidenhead, in the County of Berkshire, and Heathrow Airport, in the London Borough of Hillingdon, through central London to Shenfield, in the County of Essex, and Abbey Wood, in the London Borough of Greenwich; and for connected purposes.
2. The Bill is presented by the Secretary of State for transport.
3. Amendment of Provisions of the Crossrail Bill (hereinafter referred to as “the Amendments”) has been introduced and is now pending in your honourable House. intituled “Amendment of Provisions (May 2007)”.
4. Your Petitioner is an owner of properties in the Royal Arsenal, Woolwich London SE18, particularly Units 1, 2, 3, 4, 5 and 6 The IO Centre.
5. Your Petitioner and its rights, interests and property are injuriously affected by the Amendments, to which your Petitioners object for reasons amongst others, hereinafter appearing.
6. The proposals will result in: -
 - a) Loss of access by way of Cornwallis Road

- b) Loss of use of Arsenal Way
 - c) Loss of use of Units 1, 2 and 3 The IO Centre
 - d) Permanent loss of car parking and circulation area.
7. These losses will have a significantly detrimental effect on the capital and rental values of such property, and in some cases will result in great difficulty or impossibility of reletting or selling any part thereof.

YOUR PETITIONERS therefore humbly pray your Honourable House that the Amendments may not be allowed to pass into law as it now stands, or that such other relief may be given to your Petitioner in the premises as your Honourable House shall deem meet.
