Introduction

1. Two vacancies for external members of the Bank of England's Prudential Regulation Committee (PRC) arose as a result of Charles Randell and David Thorburn resigning their positions on the Committee.¹
2. The Treasury announced that Jill May has been appointed as an external member of the Bank of England's PRC on 18 June 2018. Her appointment took effect from 23 July 2018 for a period of three years.²
3. This is the first time that the Committee has considered the appointments of external members to the PRC. In this Report, the Committee has considered the suitability of Jill May for this role against the criteria of personal independence and professional competence.
4. The Committee took oral evidence from Jill May on 12 September 2018. She provided a full CV and answered a written questionnaire prior to giving oral evidence. The Committee would like to thank Jill May for this evidence, which has been published on the Treasury Committee website.³

The appointment of Jill May

Background on Professor Jill May

5. Jill May is an experienced investment banker, having most recently worked at UBS as Managing Director and Head of Cross Banking Strategy for Europe, Middle East and Africa. Prior to this she worked at S.G. Warburg Limited.

6. Since leaving UBS, Jill May has had a number of non-executive appointments including as non-Executive Director at JP Morgan Claverhouse and Ruffer Investment Company. In addition, Jill May serves as a member of the Durham University council and as a non-Executive Director at the Institute of Chartered Accountants of England and Wales.

Oral evidence

7. In oral evidence, the Committee questioned Jill May about her prior experience as well as wider questions on the role of the Prudential Regulation Authority (PRA). Topics covered during the session included:

- The tolerance of the Prudential Regulation Committee (PRC) around firm failure;
- The PRC's work on operational resilience and concerns around cyber-crime;
- Jill May's ongoing commitments and non-Executive roles;
- Jill May's role on the PRC including providing challenge in technical discussions;
- The benefit of liaison between external PRC members and industry experts including regulated firms;
- The utility of stress testing as a method for testing firm resilience;
- Any softening of the US financial regulatory system;
- The effects of the financial crisis on consumers and regulated firms;
- The risks around the UK exiting the European Union and the necessary work that needs to be undertaken by the PRA;
- Regulated firms' preparedness for the UK exiting the European Union;
- The role of women in finance and an assessment of the ongoing work on diversity and culture in financial services; and
- How climate change can manifest as a financial risk in regulated firms.

Conclusion

8. The Committee is satisfied that Jill May has the professional competence and personal independence to be an external member of the Prudential Regulation Committee of the Bank of England. We wish her every success in her new role.
