

COVID-19: European Scrutiny Committee consideration of the EU's policy response (*Updated: 15 July 2020*)

Introduction

The UK left the EU on 31 January 2020, but has agreed to continue applying EU legislation until the end of a post-Brexit transition period due to end on 31 December 2020.¹

During this time, the European Scrutiny Committee therefore still assesses legislative proposals and policy papers produced by the EU on the basis of their formal 'deposit' in Parliament by the Government (which also produces Explanatory Memoranda for each such EU document, setting out the UK's official position). The Committee then publishes its assessment of the European proposals' relevance for the UK during the transition period, as well as in the context of the Ireland/Northern Ireland Protocol in the Withdrawal Agreement and the future UK-EU economic and security relationship.²

Consideration of the EU policy response to the COVID crisis

A particular focus of the Committee's work in the first half of 2020 has been the EU's response to the COVID-19 (coronavirus) pandemic and the associated economic crisis. Because the EU has the ability to legislate in many areas relevant to the crisis, including standards for medical equipment and support for sectors hit hardest, like transport, numerous coronavirus-related policy changes have been announced at European level since early March 2020.

During transition, any changes to EU rules adopted in response to the crisis will also apply in and to the UK. The Committee has therefore prioritised assessment of COVID-related EU proposals as much as possible. The outcome of the Committee's analysis on the most important proposals and documents is set out in its weekly reports, beginning with its [Report of 26 March 2020](#).

To aid other Select Committees and other interested parties in accessing the Committee's assessment of the EU's coronavirus policy response, the table in the Annex of this document shows all COVID-related legislative proposals and policy papers produced by the EU that the Committee has (or had) under consideration.
