Confer powers on Ministers of the Crown in relation to certain public bodies and offices; to confer powers on Welsh Ministers in relation to environmental public bodies; to make provision in relation to forestry; to make provision about amendment of Schedule 1 to the Superannuation Act 1972; and for connected purposes.

BE IT ENACTED by the Queen’s most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

General ministerial powers

1 Power to abolish

- (1) A Minister may by order abolish a body or office specified in Schedule 1.
- (2) An order under subsection (1) may include provision transferring functions from the body or office being abolished to an eligible person. 5
- (3) In this Act, “eligible person” means—
 - (a) a Minister, the Scottish Ministers, a Northern Ireland department or the Welsh Ministers,
 - (b) any other person exercising public functions,
 - (c) a company limited by guarantee, 10
 - (d) a community interest company, or
 - (e) a body of trustees or other unincorporated body of persons.

2 Power to merge

- (1) A Minister may by order merge any group of bodies or offices specified in Schedule 2. 15
- (2) In this section, to “merge” a group means—

- (a) to abolish all the bodies or offices in the group, create a new body corporate or office and transfer some or all of the functions of the abolished bodies or offices to the new one, or
- (b) to abolish all but one of the bodies or offices in the group and to transfer some or all of the functions of the abolished bodies or offices to the remaining one. 5
- (3) An order under subsection (1) may include provision to transfer a function from a body or office being abolished to an eligible person not included in the group.
- 3 Power to modify constitutional arrangements 10**
- (1) A Minister may by order modify the constitutional arrangements of a body or office specified in Schedule 3.
- (2) In this Act, references to the constitutional arrangements of a body include matters relating to—
- (a) the name of the body; 15
- (b) the chair of the body (including qualifications and procedures for appointment and functions);
- (c) members of the body (including the number of members, qualifications and procedures for appointment and functions);
- (d) employees of the body exercising functions on its behalf (including qualifications and procedures for appointment and functions); 20
- (e) the body’s powers to employ staff;
- (f) governing procedures and arrangements (including the role and membership of committees and sub-committees);
- (g) reports and accounts; 25
- (h) the extent to which the body is accountable to Ministers;
- (i) the extent to which the body exercises functions on behalf of the Crown.
- (3) In this Act, references to the constitutional arrangements of an office include matters relating to—
- (a) the name of the office; 30
- (b) appointment of the office-holder (including qualifications and procedures for appointment);
- (c) the office-holder’s powers to employ staff;
- (d) reports and accounts;
- (e) the extent to which the office-holder is accountable to Ministers; 35
- (f) the extent to which the office-holder exercises functions on behalf of the Crown.
- 4 Power to modify funding arrangements**
- (1) A Minister may by order modify the funding arrangements of a body or office specified in Schedule 4. 40
- (2) In this Act, references to modifying the funding arrangements of a body or office include—
- (a) modifying the extent to which it is funded by a Minister;
- (b) conferring power on the body, or the office-holder, to charge fees for the exercise of a function (and to determine their amount). 45

5 Power to modify or transfer functions

- (1) A Minister may by order –
 - (a) modify the functions of a body, or the holder of an office, specified in Schedule 5, or
 - (b) transfer a function of such a person to an eligible person. 5
- (2) In this Act, references to modifying the functions of a person include –
 - (a) conferring a function on the person;
 - (b) abolishing a function of the person;
 - (c) changing the purpose or objective for which the person exercises a function; 10
 - (d) changing the conditions under which the person exercises a function.

6 Power to authorise delegation

- (1) A Minister may by order authorise a body, or the holder of an office, specified in Schedule 6 to enter into arrangements with an eligible person for a function exercised by the body or office-holder to be exercised by the eligible person. 15
- (2) Arrangements made under an order under subsection (1) may, subject to the provisions of the order, provide for the exercise of the function by the eligible person –
 - (a) unconditionally or subject to such conditions as may be specified in the order or the arrangements; 20
 - (b) for such period, not exceeding ten years, as may be so specified.
- (3) Arrangements made under an order under subsection (1) –
 - (a) may be revoked at any time by the body or office-holder authorised to enter into them;
 - (b) do not prevent the body or office-holder from exercising the function to which the arrangements relate; 25
 - (c) do not affect the responsibility of the body or office-holder in relation to the function.

7 Consequential provision etc

- (1) An order under sections 1 to 6 may make consequential, supplementary, incidental or transitional provision, or savings. 30
- (2) Where an order under sections 1, 2 or 5(1)(b) transfers functions, the power in subsection (1) includes power to make consequential or supplementary provision –
 - (a) to modify functions of the transferor or transferee; 35
 - (b) to modify the constitutional or funding arrangements of the transferor or transferee.
- (3) Where an order under section 5(1)(a) modifies functions of a body or office-holder, the power in subsection (1) includes power to make consequential or supplementary provision to modify the constitutional or funding arrangements of the body or office. 40
- (4) Where an order under section 6 authorises arrangements for the exercise of functions by an eligible person who exercises public functions, the power in

subsection (1) includes power to make consequential or supplementary provision –

- (a) to modify the eligible person’s public functions, or
- (b) to modify the eligible person’s constitutional or funding arrangements.

General ministerial powers: supplementary

8 Matters to be considered

- (1) In considering whether to make an order under sections 1 to 6, the Minister must have regard to the following objectives –
 - (a) achieving increased efficiency, effectiveness and economy in the exercise of public functions; 10
 - (b) securing appropriate accountability to Ministers in the exercise of such functions.
- (2) A Minister may make an order under those sections only if the Minister considers that –
 - (a) the order does not remove any necessary protection, and 15
 - (b) the order does not prevent any person from continuing to exercise any right or freedom which that person might reasonably expect to continue to exercise.

9 Devolution

- (1) An order under sections 1 to 6 requires the consent of the Scottish Ministers to make provision which would be within the legislative competence of the Scottish Parliament if it were contained in an Act of that Parliament. 20
- (2) An order under sections 1 to 6 requires the consent of the appropriate Northern Ireland department to make provision which would be within the legislative competence of the Northern Ireland Assembly if it were contained in an Act of the Assembly. 25
- (3) Consent is not required under subsection (2) in relation to any provision if a Bill for an Act of the Northern Ireland Assembly containing the provision would require the consent of the Secretary of State under section 8 of the Northern Ireland Act 1998. 30
- (4) An order under sections 1 to 6 requires the consent of the Welsh Ministers to make the following –
 - (a) provision which would be within the legislative competence of the National Assembly for Wales if it were contained in a Measure of the Assembly (or, if the order is made after the Assembly Act provisions come into force, an Act of the Assembly); 35
 - (b) provision not falling within paragraph (a) which –
 - (i) modifies a function of the Welsh Ministers, the First Minister for Wales or the Counsel General to the Welsh Assembly Government, or 40
 - (ii) could be made by any of those persons.
- (5) In subsection (4)(a), “the Assembly Act provisions” has the meaning given by section 103(8) of the Government of Wales Act 2006.
- (6) In subsection (4)(b), references to a function do not include –

- (a) a function of giving consent to, or being consulted about, the exercise of a function by a Minister, or
- (b) a function relating to the constitutional arrangements of a body or office.

10 Procedure for orders 5

An order under sections 1 to 6 may not be made unless a draft of the instrument containing the order has been laid before, and approved by a resolution of, each House of Parliament.

Addition to bodies and offices subject to general ministerial powers

11 Power to amend Schedules 1 to 6 10

- (1) A Minister may by order amend any of the principal Schedules by adding a body or office specified in Schedule 7.
- (2) In this section, “the principal Schedules” are Schedules 1 to 6.
- (3) In the case of Schedule 2, the power in subsection (1) may be exercised –
 - (a) by adding a body or office to an existing group in that Schedule, or 15
 - (b) by adding two or more bodies or offices as a new group.
- (4) The power in subsection (1) may not result in a body or office being specified –
 - (a) in Schedule 1 and another of the principal Schedules, or
 - (b) in Schedule 2 and another of the principal Schedules.
- (5) Where an order under sections 3 to 6 is made in relation to a body or office specified in any of the principal Schedules, the order may remove the body or office from that Schedule. 20
- (6) An order under section 2 may add to Schedule 7 –
 - (a) a new body or office created under section 2(2)(a), or
 - (b) the remaining body or office referred to in section 2(2)(b). 25

12 Procedure for orders under section 11

- (1) An order under section 11(1) may not be made unless a draft of the instrument containing the order has been laid before, and approved by a resolution of, each House of Parliament.
- (2) An order under section 11(1) may not be included in the same instrument as any other order under this Act. 30

Powers of Welsh Ministers

13 Powers relating to environmental bodies

- (1) The Welsh Ministers may by order modify –
 - (a) the functions of the Countryside Council for Wales (“the CCW”), 35
 - (b) the functions of the Environment Agency, so far as relating to Wales, or
 - (c) the functions of the Forestry Commissioners, so far as so relating.

- (2) The Welsh Ministers may by order transfer any function of the CCW to—
- (a) a new body,
 - (b) the Welsh Ministers,
 - (c) the Environment Agency or the Forestry Commissioners, or
 - (d) any other person exercising public functions in relation to Wales. 5
- (3) The Welsh Ministers may by order transfer any function of the Environment Agency or the Forestry Commissioners, so far as relating to Wales, to—
- (a) a new body,
 - (b) the Welsh Ministers,
 - (c) the CCW, or 10
 - (d) any other person exercising public functions in relation to Wales.
- (4) The Welsh Ministers may by order transfer any function of theirs relating to the environment to—
- (a) a new body,
 - (b) the CCW, or 15
 - (c) the Environment Agency or the Forestry Commissioners.
- (5) The Welsh Ministers may by order transfer any Welsh devolved function relating to the environment from the person whose function it is to—
- (a) a new body,
 - (b) the CCW, or 20
 - (c) the Environment Agency or the Forestry Commissioners.
- (6) The Welsh Ministers may by order establish a body corporate for the purposes of this section; and in this section references to a “new body” are to any body so established.
- (7) The Secretary of State’s consent is required for an order under this section which—
- (a) modifies the functions of the Environment Agency or Forestry Commissioners, where the functions affected are not Welsh devolved functions;
 - (b) transfers a function to the Environment Agency or the Forestry Commissioners; 30
 - (c) transfers a function from the Environment Agency or the Forestry Commissioners, where the function is not a Welsh devolved function;
 - (d) transfers a function to a person referred to in subsection (2)(d) or (3)(d), where the functions exercised by the person before the making of the order are not Welsh devolved functions. 35
- (8) In this section, “Welsh devolved function” means—
- (a) a function conferred under a Measure or Act of the National Assembly for Wales,
 - (b) a function which is exercisable in or as regards Wales and relates to matters within the legislative competence of the National Assembly for Wales, or 40
 - (c) a function in relation to which—
 - (i) a function is exercisable by the Welsh Ministers, the First Minister or the Counsel General to the Welsh Assembly Government, and 45

- (ii) no function (other than a function of being consulted) is exercisable by a Minister.
- (9) In considering whether to make an order under this section, the Welsh Ministers must have regard to the following objectives –
 - (a) achieving increased efficiency, effectiveness and economy in the exercise of public functions; 5
 - (b) securing appropriate accountability to Welsh Ministers in the exercise of such functions.
- (10) The Welsh Ministers may make an order under this section only if they consider that – 10
 - (a) the order does not remove any necessary protection, and
 - (b) the order does not prevent any person from continuing to exercise any right or freedom which that person might reasonably expect to continue to exercise.
- (11) In this section, “Wales” has the same meaning as in the Government of Wales Act 2006. 15

14 Powers relating to environmental bodies: consequential provision etc

- (1) An order under section 13 may contain consequential, supplementary, incidental or transitional provision, or savings.
- (2) Where an order under that section transfers functions, the power in subsection (1) includes power to make consequential or supplementary provision – 20
 - (a) to modify the constitutional or funding arrangements of the transferor or transferee (not including the Environment Agency or Forestry Commissioners);
 - (b) to modify functions of the transferor or transferee; 25
 - (c) to confer powers of direction on Welsh Ministers in relation to functions transferred.
- (3) The Secretary of State’s consent is required for an order under section 13 making provision by virtue of subsection (1) which does not relate exclusively to Welsh devolved functions (within the meaning of that section). 30
- (4) Where an order under section 13 –
 - (a) modifies functions of the Environment Agency or Forestry Commissioners, or
 - (b) transfers functions to or from the Environment Agency or Forestry Commissioners, 35
- (5) the Secretary of State may by order make consequential or supplementary provision modifying its or their constitutional or funding arrangements.

15 Delegation etc

- (1) A body specified in subsection (2) may make arrangements with a body specified in subsection (3) for – 40
 - (a) a function of one to be exercised by the other,
 - (b) the provision of administrative, professional or technical services by one to the other, or
 - (c) co-operation in relation to the exercise of their respective functions.

- (2) The bodies in this subsection are –
- (a) the Environment Agency, and
 - (b) the Forestry Commissioners.
- (3) The bodies in this subsection are –
- (a) the Countryside Council for Wales, and 5
 - (b) a body which is a new body for the purposes of section 13.
- (4) The Welsh Ministers may by order make provision about how the function of making arrangements under subsection (1) is to be discharged.
- (5) The Secretary of State’s consent is required for an order under subsection (4).
- 16 Procedure for orders under sections 13 to 15 10**
- (1) An order may not be made by the Welsh Ministers under section 13 or 15 unless a draft of the instrument containing the order has been laid before, and approved by a resolution of, the National Assembly for Wales.
- (2) An order may not be made by the Secretary of State under section 14(4) unless a draft of the instrument containing the order has been laid before, and approved by a resolution of, each House of Parliament. 15

Powers in relation to forestry

- 17 Powers relating to functions of Secretary of State**
- (1) This section applies to the functions of the Secretary of State under the following provisions of the Forestry Act 1967 – 20
- (a) section 39(2) (disposal);
 - (b) section 39(3)(a) (management and use);
 - (c) section 39(3)(b) (letting and granting of rights and interests).
- (2) The Secretary of State may by order amend the Forestry Act 1967 so as to modify the purposes or objective for which, or conditions under which, the Secretary of State exercises a function to which this section applies. 25
- (3) An order under subsection (2) may in particular secure that the Secretary of State may exercise a function to which this section applies for any purpose or unconditionally.
- (4) An order under subsection (2) may contain consequential, supplementary, incidental or transitional provision, or savings. 30
- (5) The Secretary of State may enter into arrangements with any person for that person to exercise a function to which this section applies.
- (6) Arrangements made under subsection (5) may provide for the exercise of the function by the person – 35
- (a) unconditionally or subject to such conditions as may be specified in the arrangements;
 - (b) for such period as may be so specified.
- (7) Arrangements made under subsection (5) – 40
- (a) may be revoked at any time by the Secretary of State;

- (b) do not prevent the Secretary of State from exercising the function to which the arrangements relate;
 - (c) do not affect the responsibility of the Secretary of State in relation to the function.
- (8) The Secretary of State may in particular enter into arrangements under subsection (5) with the Forestry Commissioners. 5

18 Powers relating to Forestry Commissioners

- (1) The Secretary of State may by order do any of the following in relation to the Forestry Commissioners – 10
- (a) modify their constitutional arrangements;
 - (b) modify their functions relating to England;
 - (c) transfer a function of theirs relating to England to another person;
 - (d) authorise them to enter into arrangements with another person for that person to exercise a function of theirs relating to England.
- (2) Arrangements made under an order under subsection (1)(d) may, subject to the provisions of the order, provide for the exercise of the function by the person – 15
- (a) unconditionally or subject to such conditions as may be specified in the order or the arrangements;
 - (b) for such period as may be so specified.
- (3) Arrangements made under an order under subsection (1)(d) – 20
- (a) may be revoked at any time by the Forestry Commissioners;
 - (b) do not prevent the Forestry Commissioners from exercising the function to which the arrangements relate;
 - (c) do not affect the responsibility of the Forestry Commissioners in relation to the function. 25
- (4) An order under this section may make consequential, supplementary, incidental or transitional provision, or savings.
- (5) Where an order under this section transfers a function, the power in subsection (4) includes power to make consequential or supplementary provision – 30
- (a) to modify functions of the transferee;
 - (b) to modify the constitutional or funding arrangements of the transferee.
- (6) Where an order under this section authorises arrangements for the exercise of a function of the Forestry Commissioners by another person exercising public functions, the power in subsection (4) includes power to make consequential or supplementary provision – 35
- (a) to modify the public functions of that person, or
 - (b) to modify the constitutional or funding arrangements of that person.
- (7) In considering whether to make an order under this section, the Secretary of State must have regard to the following objectives – 40
- (a) achieving increased efficiency, effectiveness and economy in the exercise of public functions;
 - (b) securing appropriate accountability to Ministers in the exercise of such functions.
- (8) The Secretary of State may make an order under this section only if the Secretary of State considers that – 45

- (a) the order does not remove any necessary protection, and
- (b) the order does not prevent any person from continuing to exercise any right or freedom which that person might reasonably expect to continue to exercise.

19 Procedure for orders under sections 17 and 18 5

An order under section 17 or 18 may not be made unless a draft of the instrument containing the order has been laid before, and approved by a resolution of, each House of Parliament.

Restrictions on powers

20 Restriction on creation of functions 10

- (1) An order under the preceding provisions of this Act may not create or authorise the creation of—
 - (a) a power to make subordinate legislation,
 - (b) a power of forcible entry, search or seizure, or
 - (c) a power to compel the giving of evidence. 15
- (2) Subsection (1) does not prevent an order from repealing and re-enacting a power.

21 Restriction on transfer and delegation of functions

- (1) An order under the preceding provisions of this Act may not transfer any function to a person not otherwise exercising public functions if that person has not consented. 20
- (2) An order under the preceding provisions of this Act may not—
 - (a) transfer an excluded function to a person not otherwise exercising public functions, or
 - (b) authorise arrangements for an excluded function to be exercised by such a person. 25
- (3) In subsection (2) “excluded function” means—
 - (a) a function of a tribunal exercising the judicial power of the State,
 - (b) a power to make subordinate legislation,
 - (c) a power of forcible entry, search or seizure, 30
 - (d) a power to compel the giving of evidence, or
 - (e) any other function the exercise or non-exercise of which would necessarily interfere with, or otherwise affect, the liberty of an individual.

22 Restriction on creation of criminal offences 35

- (1) An order under the preceding sections of this Act may not, in relation to any transfer or modification of functions, create or authorise the creation of a criminal offence that is punishable—
 - (a) on indictment, with imprisonment for a term exceeding two years, or
 - (b) on summary conviction, with— 40

- (i) imprisonment for a term exceeding the normal maximum term, or
 - (ii) a fine exceeding level 5 on the standard scale.
- (2) In subsection (1)(b)(i) “the normal maximum term” means –
 - (a) in relation to England and Wales – 5
 - (i) in the case of a summary offence, 51 weeks, and
 - (ii) in the case of an offence triable either way, twelve months;
 - (b) in relation to Scotland –
 - (i) in the case of an offence triable only summarily, six months, and
 - (ii) in the case of an offence triable either summarily or on indictment, twelve months; 10
 - (c) in relation to Northern Ireland, six months.
- (3) In Scotland, in the case of an offence which, if committed by an adult, is triable either on indictment or summarily and is not an offence triable on indictment only by virtue of – 15
 - (a) Part 5 of the Criminal Justice Act 1988, or
 - (b) section 292(6) and (7) of the Criminal Procedure (Scotland) Act 1995, the reference in subsection (1)(b)(ii) to a fine exceeding level 5 on the standard scale is to be construed as a reference to the statutory maximum.
- (4) In England and Wales – 20
 - (a) in the case of a summary offence committed before the coming into force of section 281(5) of the Criminal Justice Act 2003, the reference in subsection (2)(a)(i) to 51 weeks is to be read as a reference to six months, and
 - (b) in the case of an offence triable either way which is committed before the coming into force of section 154(1) of that Act, the reference in subsection (2)(a)(ii) to twelve months is to be read as a reference to six months. 25
- (5) Subsection (1) does not prevent an order from repealing and re-enacting a criminal offence. 30

Transfer of property, rights and liabilities

23 Transfer schemes

- (1) A scheme for the transfer of property, rights and liabilities (a “transfer scheme”) may be made by – 35
 - (a) a Minister, in connection with an order under sections 1 to 6;
 - (b) the Welsh Ministers, in connection with the transfer of a function under section 13;
 - (c) the Secretary of State, in connection with the transfer of a function of the Forestry Commissioners under section 18(1)(c).
- (2) In the case of a transfer scheme under subsection (1)(a), property, rights and liabilities must be transferred – 40
 - (a) to a Minister, where the scheme is made in connection with an order under section 3 or 4 (modification of constitutional or funding arrangements), or
 - (b) to an eligible person or a body corporate, in any other case. 45

- (3) In the case of a transfer scheme under subsection (1)(b) or (c), property, rights and liabilities must be transferred to the person to whom the function is transferred.
- (4) The things that may be transferred under a transfer scheme include—
- (a) property, rights and liabilities that could not otherwise be transferred; 5
 - (b) property acquired, and rights and liabilities arising, after the making of the scheme.
- (5) A transfer scheme may make consequential, supplementary, incidental or transitional provision and may in particular—
- (a) create rights, or impose liabilities, in relation to property or rights transferred; 10
 - (b) make provision about the continuing effect of things done by the transferor in respect of anything transferred;
 - (c) make provision about the continuation of things (including legal proceedings) in the process of being done by, on behalf of or in relation to the transferor in respect of anything transferred; 15
 - (d) make provision for references to the transferor in an instrument or other document in respect of anything transferred to be treated as references to the transferee;
 - (e) make provision for the shared ownership or use of property; 20
 - (f) if the TUPE regulations do not apply in relation to the transfer, make provision which is the same or similar.
- (6) A transfer scheme may provide—
- (a) for modification by agreement;
 - (b) for modifications to have effect from the date when the original scheme came into effect. 25
- (7) For the purposes of this section—
- (a) an individual who holds employment in the civil service is to be treated as employed by virtue of a contract of employment, and
 - (b) the terms of the individual’s employment in the civil service are to be regarded as constituting the terms of the contract of employment. 30
- (8) In this section—
- “civil service” means the civil service of the State;
 - “TUPE regulations” means the Transfer of Undertakings (Protection of Employment) Regulations 2006 (SI 2006/246); 35
 - references to rights and liabilities include rights and liabilities relating to a contract of employment;
 - references to the transfer of property include the grant of a lease.

24 Transfer schemes: procedure

- (1) A transfer scheme made by a Minister under section 23(1)(a) may be included in an order under sections 1 to 6; but if not so included must be laid before Parliament after being made. 40
- (2) A transfer scheme made by the Welsh Ministers under section 23(1)(b) may be included in an order under section 13; but if not so included must be laid before the National Assembly for Wales after being made. 45

- (3) The Secretary of State's consent is required for a transfer scheme under section 23(1)(b) transferring anything from or to the Environment Agency or the Forestry Commissioners.
- (4) A transfer scheme made by the Secretary of State under section 23(1)(c) may be included in an order under section 18; but if not so included must be laid before Parliament after being made. 5

25 Transfer schemes: taxation

- (1) The Treasury may by order make provision varying the way in which a relevant tax has effect in relation to—
- (a) anything transferred under a scheme under section 23, or 10
 - (b) anything done for the purposes of, or in relation to, a transfer under such a scheme.
- (2) The provision which may be made under subsection (1)(a) includes in particular provision for—
- (a) a tax provision not to apply, or to apply with modifications, in relation to anything transferred; 15
 - (b) anything transferred to be treated in a specified way for the purposes of a tax provision;
 - (c) the person making the scheme to be required or permitted, with the consent of the Treasury, to determine, or specify the method for determining, anything which needs to be determined for the purposes of any tax provision so far as relating to anything transferred. 20
- (3) The provision which may be made under subsection (1)(b) includes in particular provision for—
- (a) a tax provision not to apply, or to apply with modifications, in relation to anything done for the purposes of or in relation to the transfer; 25
 - (b) anything done for the purposes of, or in relation to, the transfer to have or not have a specified consequence or be treated in a specified way;
 - (c) the person making the scheme to be required or permitted, with the consent of the Treasury to determine, or specify the method for determining, anything which needs to be determined for the purposes of any tax provision so far as relating to anything done for the purposes of, or in relation to, the transfer. 30
- (4) An order under this section is subject to annulment in pursuance of a resolution of the House of Commons. 35
- (5) In this section—
- “relevant tax” means income tax, corporation tax, capital gains tax, stamp duty or stamp duty reserve tax;
 - “tax provision” means a provision of an enactment about a relevant tax;
 - references to the transfer of property include the grant of a lease. 40
